Stainless Steel Recessed Hose Box with Lumaloy Non-Skid Top for Floor Installation

These Acorn Recessed Hose Boxes are CUPC® by IAPMO certified for U.S. and Canada. Boxes are designed for attractive service in both interior and exterior floors not subject to freezing. Ideal for installation in markets and similar commercial buildings in foot traffic locations or where wall box cannot be used. Vacuum breaker models prevent accidental contamination of potable water supply.

Hose Box is seamless construction, fabricated from 18 gage, type 304 stainless steel and is furnished with four stainless steel clips for anchoring to the floor.

Frame and Door are cast Lumaloy and have a diamond tread non-skid surface. Frame is furnished with four tamper-resistant bolts for anchoring to box. Door is hinged and has a recessed cam latch which is operable with a loose key by others or the removable wheel handle on the valve.

Valve and Stop Body is cast bronze with exposed parts chrome-plated. Valve and Stop feature tamper-resistant lockshield bonnets and replaceable cartridges containing all wearing parts including the seat. The body casting is gasketed where it joins the box and is securely anchored with stainless steel tamper-resistant screws. Supply inlet is 3/4" NPT female. Outlet is 3/4" male hose thread. Special spacers are used below the hose outlet which provides a drain at this point.

-SSLF stainless steel lead free option provides a rough finish, cast stainless steel valve body, stainless steel stop assembly, stainless steel lockshield cartridge and meets the lead free requirements where the wetted surface of this product contacted by water contains less than 0.25% lead. On models that include vacuum breakers, a lead-free brass vacuum breaker is provided.

Screwdriver Stop in supply permits servicing the control valve without shutting down the water supply. Vacuum breaker models prevent contamination of the potable water supply. Vacuum breakers are atmospheric type and conform to the requirements of ASSE Standard 1011. Check local code authority for vacuum breaker requirements.

GUIDE SPECIFICATION

Provide and install Acorn Recessed Hose Box model (specify model number) for floor installation. Box shall be fabricated from 18 gage, type 304 stainless steel with satin finish interior. Door assembly shall be cast Lumaloy and have a diamond tread, non-skid surface, and cam latch operable with a loose key by others or with the removable wheel handle on the valve. Valve shall be cartridge-operated type with vandal-resistant lockshield bonnets and a removable wheel handle. Hose box shall be installed flush with floor over one cubic foot of pea gravel.


