Model A172408S-FG-VR is a self-contained, enhanced vandal resistant bi-level pressure water cooler that shall deliver a minimum of **8.0 GPH** (30.3 LPH) of water at 50°F (10°C) cooled from 80°F (26.7°C) inlet water and 90° (32.2°C) ambient. Units shall be activated by chrome plated brass front pushbuttons by using less than 5 pounds of force. Bubblers shall be Lead-Free Stainless Steel with an integrally designed non-squirt feature and operate on a water pressure range of 20-105 psig. **Unit shall be constructed from 14 gage, 304 stainless steel** with an integral drain and the louvers shall have a stainless steel protective screen. Cooling system shall use R-134a refrigerant and be capillary tube controlled. Unit shall be listed by Underwriters Laboratories for both the US and Canada and is to be compliant to ANSI/ASHRAE 18. Unit shall be certified to Public Law 111-380 (NO-LEAD) and NSF/ANSI/CAN 61. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately. Unit shall be listed by Underwriters Laboratories for both the US and Canada, compliant to the Air Conditioning and Refrigeration Institute Standard 1010.

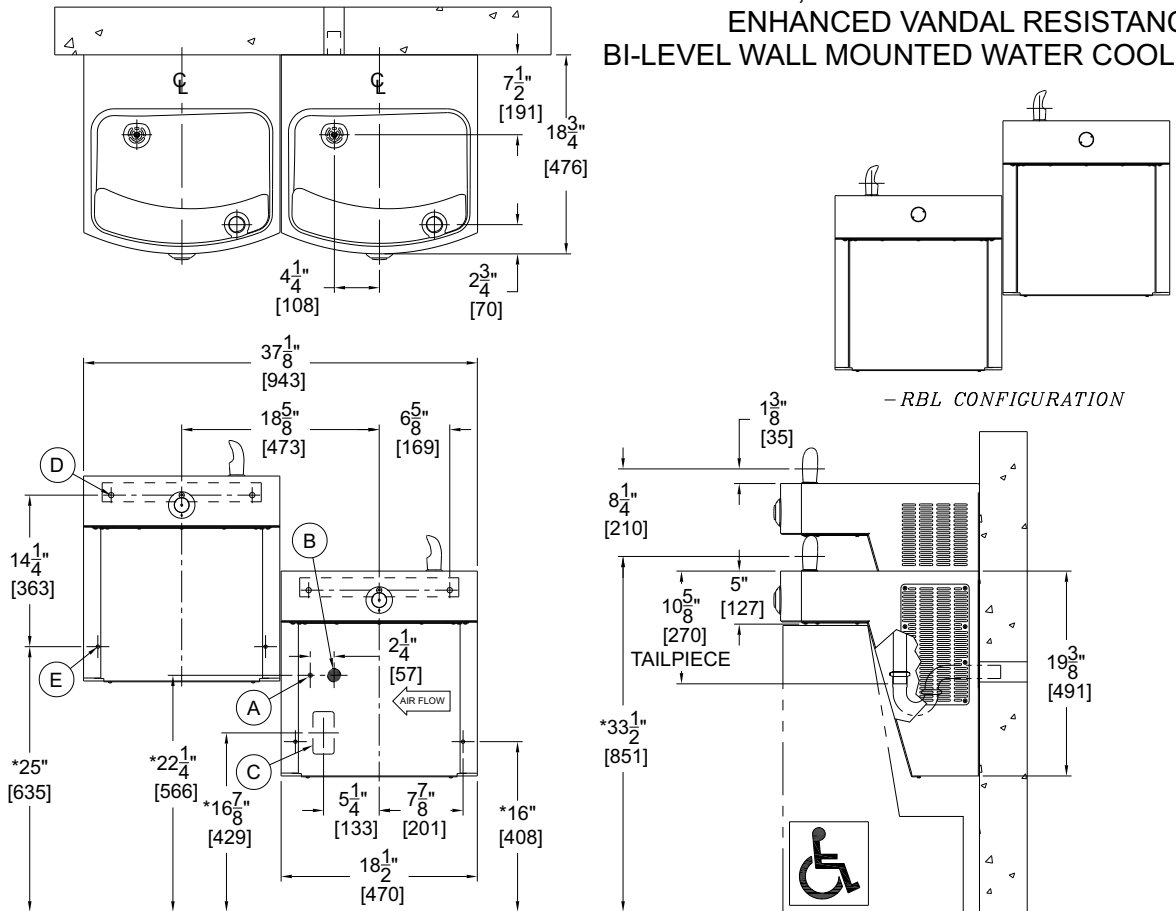
