Unit shall be activated by a surface mounted, chrome plated brass front pushbutton using less than 5 pounds of force. Bubbler shall be Stainless Steel, with an integrally designed non-squirt feature and operates on a water pressure range of 20-105 psig. Unit shall be certified to Public Law 111-380 (NO-LEAD) and NSF/ANSI/CAN 61. Optional WF3000 PFAS Water Filter shall have 3000 gallon capacity with 3rd Party Certification for Lead, Bacteria, Chlorine, Microplastics, and NSF/ANSI for Cyst and total PFAS reduction.


