Electric Refrigerated Bottle Filler

EZREACH™ Model BFEZS168 is a self-contained, Chilled Bottle Filler that delivers a minimum of **8.0 GPH** (30.3 LPH) of water at 50°F (10°C) cooled from 80°F (26.7°C) inlet water and 90°F (32.2°C) ambient. Unit shall be activated by a front mounted 9 Volt Infrared Sensor. Basin shall be constructed from 304 Stainless Steel polished to a #4 satin finish and have an Integral Drain. Cabinet shall be Stainless Steel with Satin Finish. Cooling system shall use R-134a Refrigerant and be Capillary Tube regulated. Thermostat shall regulate the refrigeration system. Unit shall be listed by Underwriters Laboratories for both the US and Canada and is to be compliant to ANSI/ASHRAE 18. Unit shall be certified to Public Law 111-380 (NO-LEAD) and NSF/ANSI/CAN 61-2020, Section 9. When installed properly, the Bottle Filler complies with ADA forward and side reach height requirements ADA Standing Person, and ADA Child. Unit shall still deliver ambient water temperature to the Spout in the absence of electrical power as long as Battery Power Pack option is used and there is a pressurized water supply. Bottle Filling unit shall include Sensor Operated activation with a 20 second maximum run time.

Bottle Filler housing construction will be 20 gauge Stainless Steel with a satin finish and will also include components manufactured from Antimicrobial, impact resistant ABS. Bottle Filler shall provide approximately 1 GPM (3.8 LPM) flow rate with a Laminar Flow Spout to minimize splashing. Optional WF3000 PFAS Water Filter shall have 3000 gallon capacity with 3rd Party Certification for Lead, Bacteria, Chlorine, Microplastics, and NSF/ANSI for Cyst and total PFAS reduction.

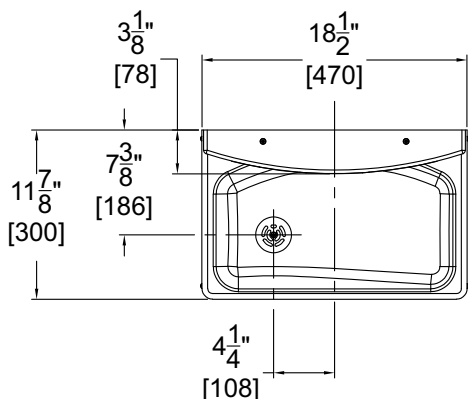

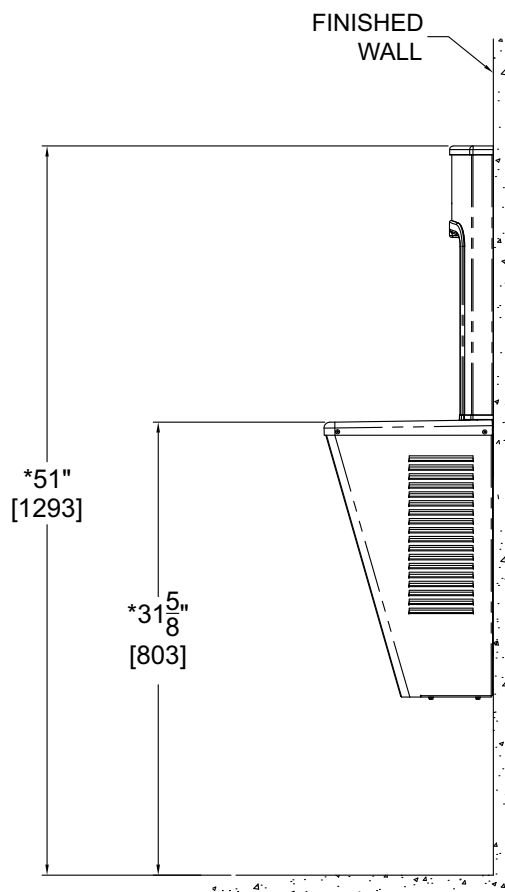
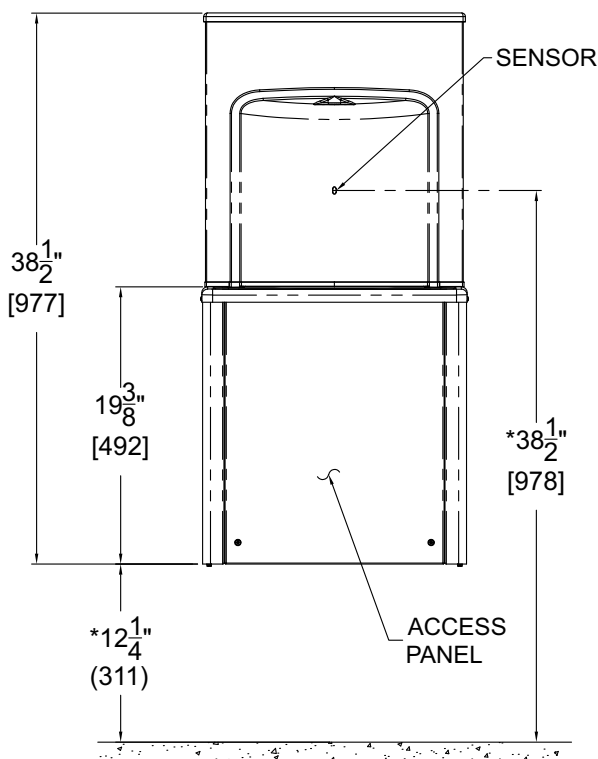
