Model GRJ85-FRU1 is a barrier free, pedestal mounted, vandal resistant, freeze resistant, round drinking fountain made from an 18 gage, 304 stainless steel bowl mounted into a green powder coated 12 gage, heavy duty stainless steel pedestal. Unit shall be activated by a front mounted pushbutton, by using less than 5 pounds of force, which pneumatically activates a water valve mounted below the frost line. An internally mounted adjustable stream regulator shall control the water flow. Bubbler shall be polished stainless steel with a non-squirt feature and operate on water pressure range of 20 - 105 psig. Unit shall be certified to Public Law 111-380 (NO-LEAD) and NSF/ANSI/CAN 61. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately.


