SUGGESTED SPECIFICATIONS

Model GSC55 is a wall mounted, vandal resistant drinking fountain made from an 18 gage, 304 stainless steel bowl mounted into a green powder coated 12 gage, heavy duty stainless steel support arm. Unit shall be activated by a front mounted self-closing button, by using less than 5 pounds of force, which activates an internally mounted valve with an adjustable stream regulator controlling the water flow. Bubbler shall be polished stainless steel with a non-squirt feature and operate on water pressure range of 20-105 psig. Unit complies with ANSI A117.1 and shall be certified to Public Law 111-380 (NO-LEAD) and NSF/ ANSI/CAN 61. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately.

INSTALLATION NOTES: Refer to installation detail to ensure fixture Mounting Channel is compatible with wall construction type.


