SUGGESTED SPECIFICATIONS

Model GVQ89-FRU3 is a barrier free pedestal mounted, vandal resistant, freeze resistant tri-level square drinking fountain made from 18 gage, 304 stainless steel bowls mounted into a reinforced brown concrete aggregate pedestal. Unit shall be activated by front mounted push buttons, by using less than 5 pounds of force, which pneumatically activates water valves mounted below the frost line. Internally mounted adjustable stream regulators shall control the water flow. Bubblers shall be polished stainless steel with non-squirt features and operate on water pressure range of 20-105 psig. Fountain is certified to ANSI A117.1, Public Law 111-380 (NO-LEAD), CHSC 116875 and NSF/ANSI 61, Section 9. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately.


